## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (hereinafter referred to as the “MOU”) is executed on this **30<sup>th</sup>** day of **November, 2025** between **Government Engineering College, Modasa (GECM)**, hereinafter referred to as the “First Party”, and **KODIYAR eSOLUTIONS LLP, Ahmedabad (KESLLP)**, hereinafter referred to as the “Second Party”. The First Party and Second Party shall hereinafter be jointly referred to as the “Parties”, and individually as a “Party.”

### **NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:**

#### **1. General Objectives**

- 1.1 This MOU establishes a framework for collaborative programmes aimed at enhancing academic and technical performance through mutually beneficial training and activities.
- 1.2 The Parties will cooperate in identifying and conducting performance-enhancing activities, including major courses, training programmes, and study tours.
- 1.3 This MOU does not impose any binding legal obligations on either Party.



**2. Specific objectives:** Cooperation between the parties under this MOU may include:

- 2.1 Exchange of knowledge, information, skills, and training between KESLLP officers and GECM faculty/ students.
- 2.2 Exchange of study delegations, including agreement on personnel, duration, and itinerary.
- 2.3 Support for short-term student visits and group study tours.
- 2.4 Mentorship support for UG/PG students in projects, design engineering, seminars and dissertations.
- 2.5 Provision of internships for students.
- 2.6 Facilitation of industrial training, expert talks, workshops, and seminars.
- 2.7 Organisation of events such as seminars, competitions, exhibitions, social and cultural events.
- 2.8 Providing project documents (ongoing/completed) for case studies.
- 2.9 Suggestions for curriculum revision and resource development based on industry needs.
- 2.10 Facilitation of introductions and recommendations to industry groups and professional organisations.
- 2.11 Assistance in placement for GECM students.
- 2.12 Offering consultancy services related to industrial properties.

**3. Project-Specific Agreements:**

For any specific collaborative projects, separate agreements outlining detailed terms, conditions, and responsibilities shall be executed.

**4. Coordination Committee:**

Each Party shall nominate a representative. Both representatives shall meet at least twice a year to monitor progress and guide collaborative activities.

**5. Expenses:**

Each Party shall bear its own travel, accommodation, and related expenses for delegates, faculty, and students.

**6. Nature of Relationship:**

The Parties shall remain autonomous and independent. This MOU does not establish a partnership, agency, or joint venture. Neither Party shall represent itself as having authority to bind the other without prior written consent.

**7. Intellectual Property:**

Each Party shall retain ownership of all intellectual property developed before the execution of this MOU.

**8. Fees:**

Where collaboration involves financial arrangements, such details shall be included in separate project-specific agreements.



#### **9. Confidentiality:**

9.1. All Parties shall maintain the confidentiality of any shared information and ensure the same from their employees, agents, or contractors. Disclosure is permitted only when:

- i. Required by law;
- ii. Required for statutory functions;
- iii. Required for law enforcement or for the implementation of this MOU.

9.2 These confidentiality obligations shall not apply to information already in the public domain, independently developed, or lawfully obtained from third parties.

#### **10. Dispute Resolution:**

In the event of a dispute, the Parties shall make all reasonable efforts to resolve the issue through negotiation.

#### **11. Relationship Between the Parties:**

It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorised to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

#### **12. Duration of The Memorandum:**

This MOU between KESLLP and GECM will remain in force for a period of 3 (three) years from the date of signing the documents, with a renewal option with mutual consent of both parties.

#### **13. Variation in the Memorandum:**

This agreement can be varied at any time by agreement between all the parties in writing.

#### **14. Termination of the memorandum:**

Any of the parties may terminate its role in the MOU by 30 calendar days' notice in writing at any time.

#### **15. Arbitration and Jurisdiction:**

Any divergence or dispute arising out of the interpretation or execution of this MOU shall be resolved through arbitration as per the **Arbitration and Conciliation Act, 1996**, with the place of arbitration being the **District Headquarters of the First Party**. This MOU is governed by Indian law, and courts in **Ahmedabad** shall have exclusive jurisdiction.


